JWF Process Solutions embarked on a two-year Knowledge Transfer Partnership (KTP) with Innovate U.K. and the University of Strathclyde, where the primary objective was to transform the business from traditional distribution to a company which sells data.

With no roadmap, and joining the company during the height of COVID-19 pandemic, I designed a system architecture which enabled oxygen measurement across NHS hospitals in Scotland. What started as a proof of concept, quickly became a production system involving the majority of NHS real estate. I reflect on this period of my career as a time when I really made a difference. Our company were awarded a CEED Scotland award, and my KTP is nominated as one of the most successful Knowledge Transfer Partnerships concluding in 2023.

Our primary system architecture consists of a myriad of AWS services. These are interconnected with NodeJS lambda functions which implement routing and alarm logic, HTTPS APIs, and caching behaviour within a Redis caching layer. As the founder, I have practical experience at all levels of the stack, from setting up DNS records and load balancers, to writing type-safe business logic, to effective database selection and query implementation.

I was quickly elevated to a more senior position within the business and now lead a team of three developers to build scalable "measurement as a service" solutions, and help to improve the company's IT infrastructure. In addition to

this, I often contribute to executive level meetings with our partners and customers. I built up a software engineering workflow from my perceptions of industry best practices, and continually seek to improve DevOps.

This process has greatly enhanced my interpersonal skills and given me the confidence to write great products with technologies I like using.
